

Term and Conditions

Earthflix Pvt Ltd (Organizer/Company) is holding an audition to choose participants for the programme " **The Next Level Dance Competition,**" which is accessible to contestants from all around India. Any Participant(s) who enters this Contest will be believed to have done so with the approval and knowledge of their parents/legal guardians.

By registering, the parent/legal guardian of the applicant(s)/participant(s) agrees to the conditions listed below and agrees to do the following:

- 1) Participant(s) shall carry and submit valid Proof of age and nationality (Emirates ID or Passport Copy) as may be required by the Company and 2 passport size photographs during the audition as may be required by the Company.
- 2) Registration form submit online and offline both.
- 3) Audition fee Rs200/- and Semifinal fee is Rs1500 (Solo)/2500 (Duet) and 3500(Group) which is non-refundable.
- 4) To participate in **THE NEXT LEVEL DANCE COMPETITION** your age must be 5-14 years for Junior category and 15-40 year for senior category.
- 5) Total Prize money **1 Lakh rupees**. It will divided into age groups. Only winner can take **cash prize 50,000/-** for each age group 5-14 age/ 15-40 age.
- 6) The Audition process will start at 10 am. The participant alone will be granted access at the venue. The Organizer reserves its right to change the venue, date and time of the Auditions at its discretion at any point of time.
- 7) The registration does not guarantee the selection or participation of the Applicant in the Audition and such selection shall be as per the sole discretion of Organize, availability of time and venue. The Applicant/Guardian shall not raise and waives any right to question the selection process, non-selection of the applicant and/or the selection of any other applicant.
- 8) For the Audition, each participant must bring their own costume and dancing equipment.
- 9) If a single Applicant submits repeated registrations, the Organizer will only consider the first complete registration. If an Applicant has been auditioned once, he or she will not be eligible to audition again unless selected in the first audition and asked to do so by the Organizer.
- 10) Inside the audition venue, no parents, relatives, or friends will be permitted. Each participant should bring one water bottle, any necessary medications, and lunch.
- 11) Any contract or agreement that prevents the applicant(s) from engaging into a management contract, recording contract, merchandising contract, or performance contract should be avoided. With the help of the Organizer.
- 12) A participant's participation in one stage of the audition does not entitle him or her to participate in the next stage of the audition. The Company reserves the right, in its sole and absolute discretion, to disqualify and/or exclude any participant at any stage of the audition without assigning any reason.
- 13) If it is discovered that the participant(s) furnished the Organizer with incorrect information, their participation will be rejected.
